1) Attendance

Councillors Ayre, King and McSweeney were present. Apologies were received from Cllr Beecroft, Jones, Lawless and Tomlinson and Ward councillors Gibbon, Marshall and Wright.

- 2) Declarations of interest As all the parish councillors lived in the village they all had personal interests. In addition Cllr Jones was a trustee of the Little Leigh Community Trust and Councillors Jones was also a trustee of the Village Hall Management Committee. Cllr Tomlinson was a Governor of Little Leigh school. Cllr Ayre declared a personal interest in the item on planning and took no part in this discussion.

4) Minutes of November meeting

5) Clerk's report

- Balfour Beatty had been appointed to carry out the work on Soot Hill.
 Councillors agreed to sign a joint letter with neighbouring parish councils regarding the delays and award of the contract.
- The Chairman would write to the MP about broadband telecoms infrastructure.
- A meeting with Canal and River Trust regarding towpath improvements was planned for 18 January.
- The Carols round the tree event had been successful.
- The Chairman would email his spreadsheet of highways defects to Cllr Wright and CWAC Highways.

6) Coronation celebration event

It was understood that the Palace did not wish beacons to be lit on 6 May. Further information was awaited from the Pageant Master. Cllr Jones would organise a meeting of interested parties in the village.

Cllr Ayre had consulted the school and nearby residents and had identified a site for a coronation bench to the right of the school. The idea had been positively received. The Clerk had contacted Highways who advised a street furniture licence was required. Cllr Ayre would organise a village clean up to be held on the weekend of 22 April.

7) Village Parking Issues

A working group would be formed to deal with the issue of poor parking in the village. The school Head teacher had written again to parents and the police were performing spot checks to educate drivers.

8) Village Hall Leadership

Mr Screen was stepping down as Chairman of the Village Hall Management Committee. A recognition event would be held and representatives of the Village Hall Management Committee and the Parish Council would meet in January to discuss succession and allocation of duties.
